



Monthly Noise Complaint

& Operations Summary

December 2019

Complaints:

Many factors contribute to the number of complaints received each month. An unusual flight may get the attention of a large group of people. Re-routed traffic from nearby airports can add more planes to the skies. Cloud cover may reflect sound. A handful of people file multiple reports, sometimes dozens on a daily basis.

Noise complaints are received via the Airport's web based noise complaint form or telephone hotline. Complaints can be correlated to specific flight operations using a combination of radar tracks, the aircraft's automatic surveillance system and the FAA flight plan system.







Noise and Operations Brief:

During December 2019, Paine Field received a total of 3,656 noise comments from the surrounding communities.

Data show that 10 households were responsible for 62% of the noise comments.

During December 2019, the Paine Field Air Traffic Control Tower recorded 6,550 flight operations. This is a 10.56% decrease in operations compared to December 2018 which had 7,323 operations. The four-year average for December is 6,956 flight operations. Total operations for December 2019 were 5.84% below the average.
